Community Emergency Response Team (CERT) training is a program that prepares you to help yourself, your family, friends, neighbors, or your community in the event of a disaster. The Bartlett Fire Department is now offering TEEN CERT training within the city.

TEEN CERT is a program designed to provide teens with hands on training in disaster preparedness, fire suppression, disaster medical (first aid and triage), and light search and rescue.

The TEEN CERT program also builds strong working relationships between emergency responders and the citizens we serve through education and interaction with members of the Bartlett Fire Department.

The TEEN CERT program is available for teenagers ages 13 through 17. This course will be held June 12-16, 8:30 am till 12:30 pm each day at Singleton Community Center. There is no fee to attend this course, however, applications will be taken on first come first served basis and space is limited.

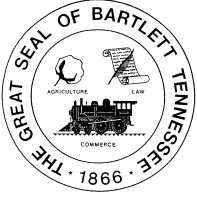

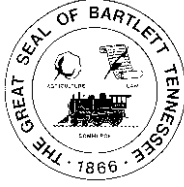
